


Just ok. I bought 'Runaway Jury', the book, b/c I saw the movie years ago and liked it. Frankly the movie producers/director did a great job on the movie from a book that's just OK & almost unreadable in my opinion; somehow they found a vision from the book that I just don't see. The writing is slow & belabored, for example, Nicholas Easter is always referred to as Nicholas, never Nick as he is in the movie, which would make the book read faster; Herman Grimes is always Herman Grimes 2-3x in one friggin' paragraph, never just Herman, & he's the only character in the book named Herman, plus I don't have Short-Term Memory-Loss so I'm pretty sure I can remember his name; ditto Mrs Herman Grimes is Always 'Mrs Herman Grimes', never Herman's wife, and apparently she doesn't have a first name. Whatever, I don't like it when authors talk-down to readers and think they can't remember the characters' names, and these annoyances make the plot Slower and the book harder to read in my opinion.
